On behalf of the members of the Veterans Education Project (VEP), which represents the interests and concerns of well over one million members of the Army and Air National Guard, their family members, National Guard retirees, and survivors, we are pleased to offer our support for the *National Guard Covid-19 Earned Benefits Guarantee Act*.

In the midst of the unprecedented national crisis brought upon by Covid-19, members of the National Guard have diligently shown their great worth and dedication to people of this nation. Over 40,000 National Guard servicemembers have been activated on title 32 § 502(f) orders as early as March, performing critical service to assist overwhelmed health care infrastructures by building new testing centers, testing civilians, sanitizing facilities, and providing humanitarian aid to Americans in need. It is evident that without the aid of these troops many states would not have had the resources available to respond to this crisis efficiently, and an untold number of American lives have been saved by these servicemembers coming to their communities' aid.

And yet, it seems with clear foresight that these servicemembers' orders have been cut to 89 days—one day short of the required threshold of eligibility—in order to deny them access to any federal benefits for serving on the front lines of this pandemic. As states have called out for continued aid from the National Guard, whose orders were to end at the end of May, their orders were extended for a peculiar 24 days, ending in the middle of the week, with no clear reason other than to deny them eligibility for education benefits and retirement.

On behalf of our membership, the Veterans Education Project thanks all of you for your service and commitment to the servicemembers and veterans of the National Guard. The *National Guard Covid-19* Earned Benefits Guarantee Act is a landmark piece of legislation that makes great strides in ensuring our members receive not only the benefits but honor they deserve. We look forward to working with you and your staff to advance this important piece of legislation.
